Terms & Conditions: -

1. The consultants shall take all safety measures for satisfactory completion of the work at his own cost and he shall be completely responsible for any mishap occur during execution of the consultancy work.
2. No T & P will be provided by the DTC.
3. All valid/mandatory taxes will be deducted as per Govt. rules from consultants bill.
4. Consultants/Architects shall ensure compliance of all statutory provisions of Govt.
5. This work order can be cancelled/stopped at any time by the Engineer-in-Charge of the work or by any officer superior to him in authority.
6. The rates quoted by the agency shall include all the applicable taxes like GST etc. & nothing extra on account of taxes shall be payable.
7. The 2.5% security shall be deducted from the running/final payments & same shall be released after a period of 6 months after date of satisfactory completion of the work.
