In pursuance to DTC Board Resolution No.7/2022 (Item 8/2022) dated 25.02.2022, vide which the Board has accorded administrative approval to fill up the vacant sanctioned post of CGM (Tech.) as per past precedent and convention from the eligible officers from technical side falling in the zone of consideration by convening the Meeting of Selection Committee constituted vide Resolution No. 14/2020 dated 23.10.2020 and thereafter minutes of the Selection Committee be placed before Chairman, DTC for consideration, approval and further action thereof.


On the recommendation of the Selection Committee, the Chairman DTC is pleased to order the promotion of Sh. Arun Kumar Kakkar, Dy. CGM (Mech.), P.T. No. 53275 to the post of CGM (Tech.) (grade pay of Rs. 8700/-) (pay matrix level 13 in 7th P.C.) with immediate effect on regular basis. In case, any disciplinary/chargesheet case is pending against him, he will not be treated to have been promoted to the post of Chief General Manager (Tech.).

The other terms and conditions of his promotion and service shall be those as embodied in the DRTA (Conditions of Appointment and Service) Regulations, 1952 as amended up-to-date and as may be amended hereinafter by Delhi Transport Corporation. He will also be governed and bound by all other Rules & Regulations framed by Delhi Transport Corporation hereinafter.

The fixation of pay on promotion will be announced separately, if required. He can exercise his option within one month for re-fixation of pay under FR. 22(1)(a)(I). In case the benefit of financial up-gradation has already been extended to him under ACP/MACP Scheme, his pay need not to be fixed /revised at this stage.

He is requested to report to MD DTC for further duties.
