CIRCULAR

Sub: DOA Login by authorized users only to stop unauthorized access

During weekly review of AFCS project meetings chaired by the competent authority, it was informed that while using various Applications of AFCS project in depots, the users are not logging into the application by using their own login credentials. Many users in depots continue to work using previous user's login. In such a situation, default by any unauthorized user would not only make the person responsible in whose name the application stands logged-in but it may pose security threats to AFCS as a whole if this practice is not stopped immediately.

- 2. Login credentials have been already provided to all users in all depots for all Depot Operation Applications (DOA). All the Depot Managers must ensure that all users use their own login credentials while working on the system. The main users from DTC depot officials are (i) Cashiers and (ii) Ticket Section officials. Similarly the users from IA side are FMEs. The roles of these users have been also enclosed for reference.
- 3. In case any new user is deployed by depot authority, then the new incumbent must be allowed to work only after obtaining login credentials for him/ her. If there is any existing user not having obtained login credentials and still working on others' login credentials, then login credentials for such users must be obtained by the concerned Depot Managers from Sh. Shamim Akhtar, Sr. Project Manager of IA immediately.

Jiolations of these guidelines are likely to pose security threats to the AFCS project. The concerned Depot Manager would be responsible for any security lapse on this account for allowing any unauthorized person to use DOA in any shift.
