Subject:- Observation of Traffic Rules by the Drivers of DTC.

The Transport Department, Govt. of N.C.T. of Delhi had launched a special drive to educate the Drivers to stop their buses at a designated place at the bus stop. The aforesaid drive has already completed and now the Enforcement Wing of Transport Department will issue challans if any driver is found to stop the buses at the middle of the road for boarding and de-boarding of passengers.

The instructions have time and again been issued vide letter CGM(O)/DTC/2015/1980-2034 dated 24.09.2015 and again vide letter No. CGM(O)/2017/314-368 dated 23.06.2017 asking the Drivers to stop the buses at a designated place at the bus stop to facilitate proper boarding and de-boarding of passengers and also not to create any hindrance to the smooth flow of traffic. However, the instances are still coming where the Drivers stop the buses at the middle of road to pick up and drop the passengers. This has been viewed very seriously.

All Regional Managers and Depot Managers are required to issue the instructions again in this regard and take strict disciplinary action if any violation of aforesaid instructions is reported to them through any challan from DTC Checking Officials or from the outside Government agencies like Traffic Police and Enforcement Department, GNCTD.

Attention of all Regional Managers and Depot Managers is invited to this office circular No. CGM(O)/DTC/2015/1980-2034 dated 24.09.2015 vide which the instructions were issued to ask all Drivers to stop buses at the designated place at the bus stops for boarding and de-boarding of passengers. However, the complaints are still coming that Drivers stop their buses at the middle of the road away from the bus stop which not only cause hindrance to the smooth flow of traffic but also causes great inconvenience to the passengers.

Instructions are again issued to all Regional Managers and Depot Managers to instruct the Drivers to stop the buses at a designated place at the bus stop to facilitate proper boarding and deboarding of passengers and also not to cause hindrance to the smooth flow of traffic. The Checking officials who are in the field shall also be instructed to check these aspects during their course of checking and submit report if any driver is found violating the instructions.

The compliance of these instructions shall be ensured in true letter and spirit, failing which strict disciplinary action be taken against the erring officials.

It has been observed that some of the drivers stop the buses at the middle of the road away from bus stop which not only cause great inconvenience to the commuters boarding and alighting but also obstruct the smooth flow of traffic. The instructions in this regard have time and again been issued asking the drivers to park the bus properly at bus stand so as to facilitate proper boarding and de-boarding of the passengers. But these instructions are not being complied with in true spirits.

The instructions are again issued to RMs/DMs to instruct each driver to stop the bus at a designated place at bus stop to facilitate proper boarding and de-boarding of passengers and also not to cause hindrance to the smooth flow of traffic. The checking officials who are in the field shall also be instructed to check these aspects during their course of checking and submit report if any driver is found violating these instructions.

Non compliance of these instructions shall be viewed seriously and strict disciplinary action be taken against the erring staff.
