**Sub.: Strike call given by the DTC Sanyukt Morcha,  
Auto-Rickshaw and other Unions for 20<sup>th</sup> and 21<sup>st</sup>  
February 2013.**

Dear Sir,

I would like to bring to your kind notice that Sanyukt Morcha of DTC workers, Auto-Rickshaw Unions and various Central Trade Unions have given a call to go on strike for two days on 20<sup>th</sup> & 21<sup>st</sup> Feb., 2013. The Corporation is making efforts to maintain normal bus service operation in the City.

The bus operation of the Corporation starts from 4.30AM with major outshedding of buses occurring between 6.30AM to 9.00 AM. The outshedding of buses is completed by 9.30AM in the morning shift. In the evening shift the major outshedding of buses happens from 3.00 p.m. to 5.00 p.m. In view of the Strike threat, there is a possibility of staff agitation in front of the DTC Depots/ Office Premises and on roads as well. It is absolutely essential that outshedding of buses is not allowed to be hampered by any gathering of agitators or any subversive activity e.g. deflating tyres, blocking the Depot Gates or any other acts of vandalism.

In order to ensure smooth operations and to prevent Buses/Government premises/property from damages to ensure availability of Bus services to the general public, it is requested that adequate police personnel may be deputed at DTC premises especially at all the DTC Depots on both the days from early 4.30 A.M. It must be emphasised that sufficient Police presence should be ensured during the peak outshedding periods in both morning and evening shifts. It may be mentioned here that Millennium Depot Complex is having four depots with 800 buses of DTC and 200 of cluster with concentration of contractual operational staff and would need additional deployment of Police accordingly. It would be preferable in case the Police force is deployed at the Depots from the night of 19-2-2013 ( 8 p.m. onwards) to prevent any damage to the buses by the agitators at night itself in an attempt to stop the outshedding of buses in the morning of 20-2-2013.

Similarly, the buses could be prevented from operation on the road and important terminals and agitators may cause injuries to the crew and commuting Public apart from damages to the Govt. property, therefore, deployment of adequate force at Terminals and important bus stands will also help in maintaining bus services in the City.

Your cooperation and adequate deployment accordingly is solicited please.
