Resolution No.49/2011 :Item 46/2011: Hiring Charges for Low Floor  
Buses for shooting purposes.

The Board in view of the position explained in the agenda item and after detailed discussions thereon accorded approval for the following:

1. Minimum hire charges of Rs. 25,000/- (excluding detention charges) is fixed for providing Low Floor A.C. buses for shooting purposes.
2. Minimum hire charges of Rs. 20,000/- (excluding detention charges) is fixed for providing Low Floor non A.C. buses for shooting purposes.

Sub: Hiring Charges for Low Floor Buses for shooting purposes.

Brief History of the Case:-

DTC provide its buses to the general public on the rates approved by GNCTD (*Annexure-I*) as per details given below:-

S. No.	Particulars	Standard Floor Buses (Rs.)	Low Non-AC Floor Buses (Rs.)	Low AC Floor Buses (Rs.)
1	Minimum charges per bus per day (excluding detention charges)	2000/-	3000/-	8000/-
2	Charges per K.M. (Garage to Garage)	40/-	60/-	75/-
3	Detention charges per hour	250/-	400/-	800/-
4	Night charges per bus per night between 2300 hrs. to 0400 hrs.)	250/-	400/-	600/-
5	Minimum cancellation charges per bus.	500/-	750/-	1000/-

Main issue of Consideration & Examination:

During the last two years DTC has added world class Low Floor buses in its fleet. The present fleet of Low Floor buses consist A.C and non-A.C. buses. Number of requests are coming from individuals/companies to hire these buses for the purpose of shooting film etc. Presently, no rates for shooting purposes are fixed and as a result the buses are being given on the normal hiring rates and thereby Corporation is loosing a considerable amount. It is therefore proposed that the minimum hiring charges for hiring the Low Floor Buses for shooting purposes may be fixed as under:-

Low Floor A.C. Buses = Rs. 25,000/- per bus per day (excluding detention charges).

Low Floor Non A.C. Buses = Rs. 20,000/- per bus per day (excluding detention charges).

The matter is placed before the Board for consideration and approval of the following:-

2. Minimum hire charges for providing Low Floor non A.C. buses for shooting purposes. = Rs. 20,000/- (excluding detention charges)
