**Sub:-Amendment in existing Recruitment Rules for  
consideration for the post of TTC & Asstt.Cashier**



In view of above Board Resolution, henceforth column 6 of Recruitment Rules for the post of Ticket Talley Clerk and Assistant Cashier as approved and amended will be read as under:-

Column No.	Description	Approved RRs for the post of TTC/Asstt.Cashier
6	Education & other qualification required	Delhi Sr.School Certificate from CBSE or an equivalent public examination conducted by a recognised Board.  <b>Note:</b> Those who passed prior to 1979 the Higher Secondary Examination or 11 <sup>th</sup> Class examination conducted by the CBSE or equivalent public examination conducted by a recognised Board shall also be considered eligible.
