Confirmation of minutes of 3rd meeting of 2017 of the DTC Board held on 20.6.2017.

The Draft Minutes of the DTC Board Meeting held on 20.6.2017 was circulated on 27.6.2017. Since no corrections/modifications have been received from the Directors, the afore-said Minutes was confirmed.

Resolution No. 30/2017: Item 30/2017: Allotment of space in various units of the Corporation for opening of Juice Stall to Govt. agencies, AMUL Gujarat Co-Operative Milk Marketing Federation Limited & other Co-operative Ltd. Establishment at par with Mother Diary.

(Shri V.K.Gupta, CGM (Estate) was called in.)

The Board considered the Agenda Item and accorded approval for allotment of Stall site to M/s AMUL Gujarat Co-Operative Milk Marketing Federation Limited & other Co-operative Ltd. Establishment on rental basis on the similar terms & conditions as in the case of Mother Dairy as was approved by DTC Board vide Resolution No.7/2014 and Resolution No.77/2015 to generate non-traffic revenue subject to the condition that space allotted falls within the precinct of DTC.

2. The Board further authorised CMD, DTC to allot the space for juice stall or any other products to any Govt. agencies/ Co-operative Ltd. establishment on similar terms & conditions in future.

Resolution No. 31/2017: Item 31/2017: Purchase of 32 nos. new DG Sets 30 KVA against replacement of old/scrapped DG Set for various DTC Depots.

The Board considered the Agenda Item and after detailed discussion, directed that the possibility of CNG based Generator Set may be explored. The possibility and feasibility of using old Standard

Floor CNG bus engines of the scrapped buses of DTC into Generator Sets for power generation may be explored taking into account all the parameters with regard to pollution etc. and also the financial implications arising out of it.

The Board considered the Agenda Item and after detailed discussion, directed that:

i) It should be ascertained whether the price of 4539 parts of M/s Ashok Leyland Ltd. duly approved by ASRTU as brought out in Para –II (3) of the Agenda Item are also available on DGS&D – Rate Contract and if so, whether the requirement of Clause 35.2 are being fulfilled or not.

- The list of spare parts commonly used in CNG LF TATA Buses and Ashok Leyland Buses be identified and a comparative price statement of frequently used items from among these common parts be prepared to find out if there is any difference between the prices submitted by the Vehicle Manufacturers.

Resolution No. 34 /2017: Item 34/2017: Payment of damage charges to L&DO, Government of India – Remodelling of DTC Bus Depot at I.P. Estate including Headquarter building.

The Board considered the Agenda Item and in view of the position explained therein, accorded approval for releasing the payment amounting to Rs.1,41,24,065/- (Rupees one crore forty one lakh twenty four thousand sixty five only) with interest up to date as demanded by L&DO on account of damage charges towards unauthorized construction and ground rent for the period from 16.01.1992 to 14.01.2015, from DTC's own resources.

2. The Board, therefore, desired that the matter be referred to CVC apprising the factual position on above lines and obtain its advise accordingly.

Ashok Leyland Ltd. Pr. Secretary (Finance), GNCTD and Secretary (Transport), GNCTD suggested the names of Shri A.K.Singh, Dy. Secretary (Finance) and Shri Anil Banka, Spl. Commissioner (Admn.) as representatives of Finance Department, GNCTD and Transport Department, GNCTD respectively. The Board further decided that the Committee shall be headed by Shri Subhash Chandra, CGM, DTC.
