At the outset of the Sports Board Meeting the following points were deliberated:

1. Reconstitution of all 7 Sports disciplines of DTC:-

It was discussed that DTC Sports teams were constituted when the recruitment on sports quota was exercised in the past. All those members included in the seven sports discipline are majorly retired and some of them are close to the age of their superannuation. In view of this it was proposed that the new teams may be constituted after nomination and trials of sports persons (Regular as well as contractual) considering the following eligibility criteria:

- i. Employees (Regular as well as contractual) may be below the age of 45 years except the national/state level sport player.
- ii. Employees (Regular as well as contractual) may have relevant sports certificates (participation/training).
- iii. Women sports teams may be constituted subject to availability of the whole team (Regular as well as contractual).
- iv. The attendance performance of the employee for the last one year may be considered before his/her nomination. (Action by Sports Cell)

2. To strengthen all disciplines/games, trial after reconstitution of the teams with willing employees (Regular/Contractual) may be started.

It was proposed that the strengthening of the games will be focused after completion of team selections. The existing teams shall be provided appropriate time to practice between their tournaments/competitions. (Action by Sports Cell)

3. Reopen regular practice of sports teams considering upcoming Govt of NCT of Delhi inter department Sports Tournament/event 2022-23.

It was proposed that the members of the various sports teams may go for regular practice of their sports between 04:00 to 06:00 PM on Tuesdays and Thursdays of every week till further order. The Captain of various teams will ensure the attendance of the players during their practice. (Action by Sports Cell)
