During the course of Board Meeting, Joint Commissioner of Police (Traffic) Delhi/Director, DTC Board highlighted the following issues:

- 1. The problem of breakdown of DTC buses especially low floor buses and requirement of a mechanism for immediate repair of faults/removal of buses from the spot.
- 2. Sensitization and training of drivers to reduce incidents of accidents by DTC and cluster buses."
