





Terms and Conditions

1. The work shall be executed as per CPWD specification, works manual amendment up to date.
2. The contractor shall take all safety measures for satisfactory completion of the work on his own cost and he shall be responsible for any mishappening that may be occur during execution of the work.
3. No T & P will be provided by the DTC.
4. All valid/mandatory taxes will be deducted as per Govt. rules from contractor bill.
5. Any kind of damage to any part of the building, cable, electrical wiring etc during execution of the work shall be made good by the contractor at his own cost.
6. Time reckoned for completion of work 15 Days from date of issue of work order.
7. Contractor shall ensure the payment of workers in minimum wages and other social security scheme like PF, ESI Contribution and bonus etc.
8. Bidder (Contractor) must have valid Electrical Contractor license issued from Govt. of NCT of Delhi.
09. Bidder (Contractor) must have registered with any Govt. Department of NCT of Delhi/CPWD/any Govt. Department.
10. Contractor shall ensure the payment of revision of minimum wages notified by labour department every year in the month of April & October. This clause shall not only be a statutory obligation on the part of contractors but also shall ensure the legal entitlement to minimum rates of wages to workers.
11. The Engineer-in-charge of the work will accept or reject the work executed, according to his judgment.
12. This order can be cancelled and the work will be stopped at any stage by the officer in charge of the work or by officer superior to him is authorized to suspend the work similarly, the contractor may also cease work at any time with prior intimation in writing acceptable to E-in-Charge.
13. Contractor may be contacted to the office of undersigned in case of any clarification required in regard of NIQ before bid.
14. The rates are inclusive GST and Bill will be submitted by the contractor after satisfactory completion of work as per rules of the corporation.




Test certificate shall be submitted for all major items.

16. The work experience of the contractor will be three similar works minimum amount of 40% of estimated cost put to the tender or two similar works minimum amount 60% of estimated cost put to the tender or one similar work minimum amount of 80% of estimated cost put to the tender.
17. The security & Watch ward of site contractor materials/work etc shall be at cost of bidder itself. No extra amount will be paid by DTC in any case.
18. All electrical work shall be carried out in accordance with the provisions of Indian Electricity Act, 2003 and Electricity Authority (Measure Relating to Safety and Electric Supply) regulations, 2010 NEC 2011 amended to date. They shall also conform to CPWD General Specification for Electrical Works, Part-I(Internal)-2003, Part-II(External)-1994, amended to date.
