DTC intends to provide good/hygienic quality of food/snacks items to DTC staff at I.P. Estate H.Qrs. Therefore, it is looking for a good canteen contractor for DTC, H.Qrs canteen who will provide good/hygienic quality of food on DTC prescribed rates. The DTC HQrs canteen is situated in I.P. Estate near Indraprastha Metro station. It is relevant to mention here that approximately 375 to 400 employees are working in DTC H.Qrs. The canteen contractor will be provided with furniture & fixture, electricity & water free of cost. The rent of the canteen will be charged Rs.1/per month. The Terms & Conditions of DTC as well as prescribed canteen rate list of food items are enclosed for ready reference.

Terms and Conditions of the Canteen Contract

Eligibility Criteria

- i) The Contractor must possess a valid license/registration from the respective Government agency for running canteens/restaurants (copy to be enclosed).
- The experience in running the canteens of any Govt./PSU/Autonomous bodies/Pvt. Companies/educational institutes etc. shall not be less than three years.
- The Contractor should not have been blacklisted by any Govt./PSU/Autonomous bodies/Pvt.Companies/educational institutes etc.
- The Contractor should have at least one current work in hand in any Govt./PSU/autonomous bodies/Pvt. Companies/educational institutes etc.

<u>Period of Contract</u>: The contract shall be only for Eleven months and extendable to further Eleven months on the same rates and terms, based on the satisfactory performance of the contractor for running the canteen.

Forfeiture of Security Amount: The selected party will have to deposit security amounting to Rs. 3,000/-(Rupees Three Thousand Only) which is refundable but no interest will be paid on this amount. In case 3 written complaints regarding poor quality of eatable items, misbehave with the staff, overcharge in eatable items etc. received from the staff during the period of contract the security amount shall be forfeited.

<u>Furniture and utensils</u>:- DTC shall provide furniture & Fixture the quantity of furniture & other items will be handed over to the Canteen Contractor in writing at the time of awarding the canteen contract of DTC, HQrs. However, all the utensils, crockery and other supporting equipments etc. shall be arranged by the contractor himself at his own cost.

<u>Subsidy</u>:- The canteen contractor will be paid subsidy in two category A & B, Rs 14/- per employee per month for 'A' Category & Rs11/- per employee per month for 'B' category and in terms will have to serve the eatables in accordance with the rates prescribed by the Corporation and the quality and quantity of the eatables must be maintained at the desired extent.

<u>Penalties</u>:- During inspection if canteen is found unhygienic, the place of cooking and serving and utensils etc. being dirty a fine of Rs. 500/-(Rs.Five Hundred) per occasion shall be imposed. If it is observed that the quality of the eatable items are not of the desired standard as well as and there is instance of poor cleanliness of canteen, the penalty of Rs. 500/-(Rs. Five Hundred) per occasion shall be imposed.

<u>Termination of Contract</u>: In case using of electric heater found in the cooking area of the canteen or in case of breach of any of the terms and conditions, DTC shall be at liberty to terminate the contract without any notice to him and the Contractor shall have no claim for compensation for any loss that it may incur on this account. The other terms and condition in respect of Contract will be enumerated in the Agreement.

Further it is added that the canteen has been segregated in two categories naming as A & B based on the facilities maintained by the canteens.

The canteen which have facility of seating of 20 or more than 20 employees at a time and provides /serves eatable items from S.No.1 to 19 will be kept in (A) category and the amount of subsidy for such canteens is enhanced from Rs. 8/- to /Rs. 14/-.

The canteen which have facility of seating less than 20 employees at a time and provide/serves less than S.No.1 to 19 eatable items will be kept in (B) category and the amount of subsidy from Rs. 8/- is enhanced to Rs. 11/-.

The concerned RMs/Dy.CGM of Region/Unit will decide applicability of category wise subsidy for their Depot/Unit in accordance to the facility provided by the canteens under their administrative control.

The revised rates will come into force with immediate effect and Depot Managers/Unit Officers will ensure that the revised rate list is displayed in the canteens of their respective Depots/Units.

All RMs/Dy.CGM will ensure that canteens in their Regions/Units should be hygienic and provide good quality of food items by the canteen contractor/cooperative society. Any complaint in this regard should be dealt strictly.
