- (II) Self-attested Copy of Valid GST Registration Certificate and latest Acknowledgement receipt of updated filed return.
- (III) Self-attested Copy of turnover certificate duly certified by Chartered Accountant.
- (IV) Self-attested Copy of profit loss statement duly certified by Chartered Accountant.
- (V) Self-attested Copy of net worth certificate duly certified by Chartered Accountant (Form B-1).
- (VI) Self-attested Copy of PAN/TAN Registration Certificate
- (VII) Self-attested Copy of the Work Performance/Experience Certificate issued by Executive Engineer (E)/ competent authority of respective Govt. Department.
- (VIII) Self attested document related to sales, service office of supplier/ OEM.
