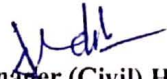

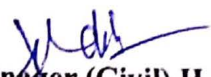

Terms & Conditions: -

1. The work shall be executed as per latest CPWD specifications with correction slip issued up to the date and as per direction of Engineer-in-charge.
2. The contractor shall take all safety measures for satisfactory completion of the work at his own cost and he shall be completely responsible for any mishap occur during execution of the work.
3. No T & P will be provided by the DTC.
4. All valid/mandatory taxes will be deducted as per Govt. rules from contractor bill.
5. Any damage to any part of the building during execution of the work shall be made good by the contractor at his own cost.
6. The contractor shall make his own arrangement for filtered & unfiltered water and electricity for use in construction and for his labour.
7. Contractor shall ensure the payment of workers in minimum wages and other social security scheme like PF, ESI contribution and bonus etc.
8. Contractor shall ensure the payment of revision of minimum wages notified by labour department every year in the month of April & October. This clause shall not only be a statutory obligation on the part of contractors but also shall ensure the legal entitlement to minimum rate of wages to workers.
9. The Officer-in-charge of the work will accept or reject the work executed, according to his judgement.
10. This order can be cancelled /stopped at any time by the officer-in-charge of the work or by any officer superior to him in authority similarly, the contractor is liable to cease work at any time.
11. The rates quoted by the agency shall include all the applicable taxes like GST etc. & nothing extra on account of taxes shall be payable.
12. The 2.5% security shall be deducted from the running/final payments & same shall be released after a period of 6 months after date of satisfactory completion of the work.
