

- 1. The work shall be executed as per CPWD specification Part-I internal 2013 with correction slip issued up to the date and as per direction of Engineer-in-charge.
- 2. The contractor shall take all safety measures for satisfactory completion of the work as his own cost and he shall be completed responsible for any mishappening that may during execution of the work.
- 3. No T & P will be provided by the DTC.
- 4. All valid/mandatory taxes will be deducted as per Govt. rules from contractor bill.
- 5. Any damage to any part of the building during execution of the work shall be made good by the contractor at his own cost
- 6. The contractor shall make his own arrangement for filtered & unfiltered water and electricity for use in construction and for his labour.
- 7. Time reckoned for completion of work 20 days from date of issue of work order.
- 8. Contractor shall ensure the payment of workers in minimum wages and other social security scheme like PF, ESI Contribution and bonus etc.
- 9. Bidder (Contractor) must have valid Electrical Contractor license issued from Govt of NCT of Delhi.
- 10. Bidder (Contractor) must have registered with any Govt Department of NCT of Delhi/CPWD/any Govt. Department.
- 11. Contractor shall ensure the payment of revision of minimum wages notified by labour department every year in the month of April & October. This clause shall not only be a statutory obligation on the part of contractors but also shall ensure the legal entitlement to minimum rates of wages to workers.
- 12. The Officer-in-charge of the work will accept or reject the work executed, according to his judgement.
- 13. This order can be cancelled the work and stopped at any stage. The officer in charge of the work or by officer superior to him is authorized to suspend the work similarly, the contractor may also cease work at any time with prior intimation in writing acceptable to E-in-Charge.



15. The rates are inclusive GST and Bill will be submitted by the contractor after satisfactory completion of work as per rules of the corporation.
