- Financial Bid are enclosed as **Annexure-A & Annexure-B respectively**. The price must be quoted as per proforma of Financial Bid given in Annexure "B". Nothing over and above the quoted price would be payable to the successful bidder. The Tenderer must quote the price The Scope of work and GeneralTerms & Conditions for this tender and proforma of both in words as well as in figures. Any over writing/cutting etc. will render the tender invalid. Submission/uploading of unwarranted/irrelevant/out of context documents online with the bid with an intension to disturb/misuse online procurement system will be taken seriously and The option in the rates will not be entertained and the tender will be rejected straightway. will not be considered for evaluation.

- 4. Online Technical Bids will be opened in the Tender Cell, Room No.207, Delhi Transport Corporation, HQs, IP Estate, New Delhi 110002. One authorized representatives of bidders may remain present at the time of bid opening, if so desire. For opening of Financial Bids, technically qualified bidders will be intimated subsequently. As per instructions of the Govt., the bidders are required to submit soft copies of their bids electronically on the e-Procurement, GNCTD Portal, using valid Digital Signature Certificates before the stipulated date & time. The person signing the tender documents should be authorized for submitting the on-line e-tender. Bidders are advised to quote their rate/price after careful study of the tender Terms & Conditions.
- 5. **Contract Period:** The validity of the contract will be for three (3) yearsfrom the date as mentioned in theWork Order by DTC.Corporation may extend the period of contract maximum upto further 1 year in case of exigency for a period required as per the circumstances, on the same rates and Terms &Conditions of the instant tender, for which the bidder will have no objection.
- 6. **Payment Terms:** The payment will be made on monthly basis as per billing of actual no. connections in use in the month. The service provider shall submit bills along with summary (both hardcopy & soft copy) in Excel format of the previous month to Sr. Manager (Communication), DTC Head Quarters and the Corporation shall make the payment within 30 days after receipt of both soft copy & hard copy (whichever is received later) of the bill along with summaryonly. TDS shall be deducted as applicable at the time of making payment of the bills. TDS Certificate will be issued after closing of financialyear. No late payment charges will be payable by DTC. The payment of the bills shall be made to the Service Provider through Electronic Fund Transfers (EFT). The bank charges, if any, for the same shall be borne by the bidder/ service provider.

- Financial BidEvaluation: The Financial Bids of technically qualified bidders
 will be opened on e-procurement portal, on the date prescribed subsequently, in
 the presence of bidderrepresentatives, if they wish to be present. The bidder should
 quote their prices only as per the financial bid format. Any conditional bid would
 berejected.
- 8. It may be noted that the contract shall be awarded to the bidder who qualifies in Technical bid evaluation and thereafter found to quote the lowest rates taking into consideration the combined financial impact of the offer provided and the offer is without any counter conditions. Offers/ quotations submitted with counter conditions or services not matching the tender requirement would be summarily rejected at Technical Evaluation Stage and no request in this regard will be entertained. Remaining offers found meeting the requirements in Technical bid, will continue to be evaluated for opening of Financial bid and selection of L1bidder.
